No.A.12026/1/2022-JE(Civil)/PWD(E) : On the recommendation of the Mizoram Subordinate Services Selection Board(MSSSB) conveyed vide I.D.No.A.32013/25/2019-P&AR(GSW) dt. 06.10.2022, the service of the following 7 (seven) Junior Engineers (Civil) are hereby regularized as per 'The Government of Mizoram Regularization of Contract Employees Scheme, 2008' at Level-7 of Pay Matrix (Rs.39,100-Rs.86,800) plus all other allowances as admissible from time to time with effect from the date of joining the post.

The above new regularized Contract Employees shall be on probation for a period of 1(one) year which may be extended for good and sufficient reasons.

Their inter-se-seniority will be determined in accordance with the list published by the Govt. and their seniority will be counted from the date of this order.

On their appointment by regularization, they are liable to be transferred anywhere within Mizoram. They should not claim transfer before completing 2 (two) years service in their posting places. On regularization, the past services rendered by them as continuous Provisional Employees and Contract Employees shall be governed by the provisions of the rules on counting of past service framed by the Government from time to time.

The appointment will be further subject to :-

- 1) Submission of declarations in the forms enclosed (Annexure A-E)
- 2) Production of Original Educational Certificate/Medical Fitness Certificate and Police verification.

They should submit joining report within 30 (thirty) days from the date of this Order, failing which their regularization will stand cancelled.
